DEPUTY SUPERVISOR'S CONCERNS

PROPOSED LOCAL LAW TO AMEND LOCAL LAW No. 1-1987

A draft of a proposed local law to amend Local Law No. 1 of 1987, as amended by Local Law No. 2 of 1989, which local law was entitled "Flood Damage Prevention Local Law" was presented by the Town Attorney, David T. Pullen. He had prepared the draft local law pursuant to a Resolution passed by the Town Board at the February 20, 2019 meeting of the Town Board. He explained that this local law was prepared to appoint the Town's Code Enforcement Officer to administer, implement and enforce the Town's Flood Damage Prevention Local Law. Apart from changing the Local Administrator the Local Law will remain exactly as it currently exists. Following discussion the following resolution was introduced by Carolyn Carney, seconded by Jill Hoopes, to wit:

BE IT RESOLVED AS FOLLOWS:

- 1. That the Town Board of the Town of Friendship accepts and proposes to adopt a local law, to be designated as Local Law No. 1 of the Year 2019 entitled "A Local Law to Amend Local Law No. 1 of 1987 entitled "Flood Damage Prevention Local Law," as amended by Local Law No. 2 of the year 1989." It repeals and deletes Sections 4, 1 and proposed the adoption of a new Section 4.1. A copy of the proposed local law is annexed hereto and incorporated into this resolution as though set out in full.
- 2. That a Public Hearing be held on April 17th, 2019 at 6:45 pm at the Public Meeting Room, located at 7 Depot St., Friendship, New York.
- 3. That the Town Clerk, with the assistance of the Town Attorney, is directed to prepare the legal Notice for timely publication in the official newspaper.
- 4. That a copy of such legal notice be posed upon the Town Clerk's bulletin board as required by law.
