Tim Steed advised this study started in 2023, to look at water supply, compliance, any issues, storage distribution. Need to look for a new water supply, water tank site, currently looking to see if the current site can be expanded.

Future funding will involve environmental studies.

Jimmy Joe stated he had started on the Water Project back in the year 2000. There was a Preliminary study in 2016 did a study and there were challenges, but good things have come from that.

Catherine Reese- what type of rock was it for the well: Tim Steed advised it was sand-stone. It was stated that there was a petroleum leak years ago at the end of 275 and Main t., was it cleaned up and the answer was that it had been cleaned up.

Dell Baker questioned if this new well would affect the neighbors having free flowing wells, Jimmy Jo responded that they cannot tell that now but their hydrogeologist would monitor this. Dell questioned if this well drilled was done with grant money and the answer was yes.

Catherine Reese stated with these Engineering reports and help of the Engineers she can look for grants and funding. Not all grants are 100% best is 70%, but no guarantee. There are deadlines, some once a year. First thing to do after the Town decides that bottom line at what they will borrow, then a Public Hearing would need to be held for discussion for a BOND RESOLUTION. This will start the process To be able to obtain grants.
